Every child should have the opportunity to participate in recreation programs. Everybody Gets to Play is a program that removes financial barriers for youth in low-income families.

WHO'S ELIGIBLE? Families with a low income, who are unemployed, who are on AISH, or who receive income support from the provincial government.

HOW MUCH MONEY IS AVAILABLE, AND WHAT PROGRAMS CAN I SPEND IT ON?

If you qualify for the Everybody Gets to Play program, you can receive up to \$250 per year per child towards Lac La Biche County recreation programs.

Ideal programs to use this funding for include the Summer Sunzone, Zumbatomics, and Rhythmic Gymnastics (among other children's programming that Lac La Biche County offers through the year).
