## Join our Corporate Membership Discount Program!

Do you want to reduce illness, sick day absenteeism, boost your organization's productivity and invest in your employee's health? The Lac La Biche County Corporate Membership Discount (CMD) Program offers businesses and organizations an opportunity to prioritize employee health and well-being through discounted annual memberships at the Bold Centre. Below is a detailed review of the CMD program.

Businesses or Organizations with 5 or more employees interested in purchasing an annual membership will receive 15% off the regular annual rates as part of the CMD program.

### Corporate Membership Benefits:

- 15 % off annual individual or family memberships. Family memberships can include up to five (5) family members residing in same residence.
- Bold Centre Access: public ice, fieldhouse open times, fitness centre, walking track and 20 drop-in passes for fitness classes.
- Portage Pool Access: public swim times and discounts on select courses.
- North Country Co-op Arena Access: public ice times (included with All Access Pass)
- 10% off fitness class registration (*combine with early bird registration for up to 25% off*)
- 2 complimentary All Access day passes.

### How to Get Started:

- A Corporate Membership Discount Agreement needs to be completed and signed by a designated representative from the business/organization.
- The Agreement needs to be returned along with a minimum of 5 employee membership applications to get started. Once the agreement is signed and submitted, the agreement is activated.
- The initial five (5) employees have 60 days to purchase their memberships after activation.
- Additional employees can join at any time after initial activation.

### The following conditions apply:

- The discount only applies to annual memberships.
- Family members do not count towards the minimum number to be eligible for corporate discount.
- Passes cannot be transferred and cannot be combined with any other membership promotions.
- Businesses/Organizations who fail to maintain the minimum requirement of five active memberships will lose discount privileges.
- If an employee is an existing Bold Centre member, they are also eligible for the discount. Accounts will be pro-rated and/or credited.
